

Seed Oil Safe Declaration



Issued by Townhall

As a verified partner in the Seed Oil Safe® program, Jordan Knight hereby declares the following:

1. Seed Oil-Free Commitment

We affirm that all food and beverage products served or prepared at our verified locations are **100% free of seed oils** and any derivatives thereof. This includes the exclusion of oils derived from seeds such as:

Canola, corn, cottonseed, flaxseed, grapeseed, hemp seed, peanut, rapeseed, rice bran, safflower, soybean, and sunflower.

We further confirm that none of our ingredients whether raw, pre-prepared, or finished contain any fractions, extracts, or chemically modified forms of seed oils, including but not limited to those found in processing aids or vitamin packs.

Notwithstanding the foregoing, single-ingredient, cold-pressed, **unrefined sesame oil** is permitted only in **unheated applications**; any item containing it must be **conspicuously labeled** on printed and digital menus and within Seed Oil Scout.

2. Ongoing Compliance

We have implemented sourcing and kitchen protocols to ensure continuous compliance with the Seed Oil Safe program. Should seed oils ever be reintroduced at any verified location, we agree to notify Seed Oil Scout in writing within five (5) business days.

We understand that failure to notify within this period may result in breach of agreement, subject to a 30-day cure period and public announcement of the breach through Seed Oil Scout's media channels.

3. Audit Rights

We acknowledge and agree that Seed Oil Scout may conduct an unannounced kitchen audit during regular business hours to verify compliance. We will provide access to all relevant materials, including menus, ingredient lists, purchase orders, procurement records, and facilities. In the event of non-compliance, we understand there will be a 30-day window to remedy the issue, after which the agreement may be terminated and liquidated damages may apply.

We stand behind this declaration as part of our commitment to clean ingredients, transparency, and consumer health.
